Budget Newsletter

Dear District Community,

We are extremely proud of our school district's programs, and we appreciate our community's support as we continue to do our best we can to provide meaningful learning opportunities and support to all of our students.

The administrative team has worked with our faculty and staff to ensure the programming and enrollment trends were accounted for, as well as the many other factors that impact the budget process. This year we present to you a responsible budget, while still preserving the wonderful programs and academics that we have grown fond of here at Hamilton Central School. In order to minimize the impact on District residents, the administrative team has found creative ways to make the proposed budget of \$15,023,304 tax cap compliant (a 3.98% tax levy increase). The allowable levy increase for the 2023-2024 school year is higher than usual due to additions to the tax base and the continued addition of debt service associated with our ongoing capital project. This keeps our academic and extra-curricular programs intact, achieving savings through efficiencies in the delivery of instructional programs.

With your commitment and support, we will be able to continue providing our students with a wealth of opportunities to develop and nurture a wide range of talents and interests.

We invite you to participate in the in-person Public Budget Hearing on Tuesday, May 9th, at 6:00 p.m.

Two board members' terms are expiring this year. Petitions to run for a three-year term have been submitted by the following: Thomas Furner, Sunghwan Choe, and Travis Ames (incumbent). The candidates have included their biographies in this newsletter for your review and will be a part of our Meet the Candidates night on May 10, 2023, at 6:00 p.m. in the HCS Auditorium. We hope you find both of these informative.

This year District voters will have the opportunity to authorize the appointment of a non-voting student representative on the Board of Education. If approved by voters, the Superintendent will select a member of the rising Senior class to serve in this role. We believe this student will provide important insight and perspective as the Board of Education deliberates District matters.

Voting for the 2023-24 school budget, Board of Education positions, the school bus proposition, Ex Officio Student Member, and the Hamilton Public Library proposition will take place on Tuesday, May 16th from 12:00 p.m. until 8:00 p.m. at the Hamilton Central School Bus Garage.

Voter requirements: U.S. citizen, 18 years of age or older and have been a resident of the school district for at least 30 days before the vote. PROPOSITION #1 - SCHOOL BUDGET

"Shall the Board of Education of the Hamilton Central School District, County of Madison, New York, be hereby authorized to expend the sum set forth in its proposed budget for 2023-24 in the total amount of \$15,023,304 and to levy the necessary tax therefore?"

PROPOSITION #2 - SCHOOL BUS

"Shall the Board of Education of the Hamilton Central School District be authorized to purchase and finance one (1) student transport vehicle, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$180,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$180,000, shall be issued."

PROPOSITION #3 - EX OFFICIO STUDENT BOARD MEMBER

"Should a high school senior student be designated to serve as an ex officio member of the Board of Education, and thereby be entitled to sit with Board Members at all its public meetings, and participate therein, but without the authority to vote on matters before the Board or to attend executive sessions?"

PROPOSITION #4 - HAMILTON PUBLIC LIBRARY

"Shall the Hamilton Central School District be authorized to levy a tax in the amount of \$156,828 and pay such monies to the Trustees of the Hamilton Public Library for the support and maintenance of the Library with such support continuing on an annual basis unless or until a different amount is authorized by the qualified voters of the school district?"

Remember, your vote is important and every vote counts. Thank you for your support of our District and your continued partnership as we work together to support our mission of "educating every student, every day."





2023-2024 Proposed School Budget Program Budget

The program budget includes all services provided directly to our students and represents approximately 72% of the expenditures in the budget. Programs budgeted in this category include the following: elementary and secondary education, occupational education, remedial and special educational programs, library and media services, inter-scholastic athletics, extra-curricular, and other direct services to students.

Instruction – This category includes the salaries for teachers, teacher assistants, and substitutes along with monies for the necessary supplies, textbooks, and equipment to support the instructional program. Funds have also been provided to support the performing arts, enrichment programs and field trips.

Special Programs – This category includes the salaries of teachers and support staff who work with children with special education needs. Also included are the expenses associated with BOCES special education programs and occupational education programs.

Interfund Transfer – Cafeteria – Funds have been provided in the budget to support the food service program. The transfer of funds will ensure the necessary revenues to offset the increase in fixed costs in this program. The general fund support is needed to offset increases in food costs, and rising employee benefit costs. It is important to us that our students have nutritious food as a mainstay of their meal.

Pupil Services – Included in this category are the costs associated with attendance, guidance, health and psychological services, and extra-curricular programs.

Transportation – This section includes all the expenses related to student transportation.

Administration Budget

This category of the budget includes administrative, financial, legal and instructional support services for the operation of the school system, as well as insurance and school board expenditures. Staff and curriculum development are also part of this budget.

Board of Education – This item of the budget includes all the expenditures incurred by members of the Board of Education and the District Clerk in the performance of their duties. Included are supplies, meeting expenses, training for new board members and expenditures such as printing, legal notices, and dues. Also, expenses for conducting district votes and elections are included.

Central Administration & Finance – This item includes expenses of the District and Business Offices, which include the superintendent, business official, secretaries, auditor, treasurer and tax collector. Other expenditures include supplies, postage, rental and repair of equipment.

Staff – Included in this category are the expenses for legal consultation, labor relations policy development and our Employees Assistance Program.

Special Items – This account includes expenses for the district's share of the BOCES administrative and capital (building) budget and for the school's insurance (liability, fire, theft, etc.).

Administration & Improvement – Included in this category are the expenses related to teacher in-service, curriculum development and the supervision of the instructional program. Funding for staff development, pre-K - 12, classroom libraries and enrichment opportunities for our students are included.

Capital Budget

Capital Services - This section of the budget includes the maintenance and operation of the school's buildings and grounds, including the custodial staff, supplies, service contracts, utility charges and maintenance equipment. It also includes debt service on our capital equipment (buses and buildings) and the benefits for employees in this category.

Central Service - Operation and maintenance of all district buildings & grounds.

Debt Service – All principal and interest payments from building projects and bus purchases. The large increase is due to new principal and interest payments for our recently completed and continuing capital improvements.
